Board Meeting Minutes 07/07/03

President Kevin Berlin, K9HX, called the July meeting of the WVARA Board to order at 6:29 PM on July 07, 2003. Club members in attendance were Vice President Gary Adams, W9EEU; Trustee Ray Andrews, K9DUR; Treasurer, Don Pine, K9DRP; Board Member at Large Dave Littlejohn, N9FMD; Station Manager Jay Sotak, AB9CG; and Natalie Andrews, K9CAT. Secretary Debbie Shorter, KC9AOR, and Past President Steve Shorter, NT9T, were not able to attend due to a family emergency. Don, K9DRP, agreed to record the minutes of the meeting. Secretary's Report: The SECRETARY'S REPORT was not available because of the Secretary's absence due to emergency. TREASURER'S REPORT: Don, K9DRP, distributed copies of the previous month's financial activity for review. The report indicated a total balance of \$3,048.69 in all accounts. Don moved that the Treasurer's Report be approved as distributed with a second by Kevin, K9HX. The motion to approve the report carried. ANNOUNCEMENTS: Kevin, K9HX, reported that the Kenwood TS-690 donated to the club checked out fine with a power output of 98 watts on 80 through 10 meters. He indicated a power cord would be needed to place the radio into operation. Kevin also expressed his thanks for the surprise card shower that took place during the repeater frequency change workshop on July 5, 2003. Club members presented Kevin with cards to express their gratitude for the many hours he spends in maintaining the repeaters and Club equipment. The September Meeting of the Wabash Valley Amateur Radio Association will be held on September 05, 2003 at 7:29 PM at the Wabash Valley Red Cross Building in Terre Haute. OLD BUSINESS: Meeting Schedule: It was discussed that a possible change in location may be pertinent for the September General Meeting due to the "Live Line Demo" slated for the meeting program. It was agreed that any change be discussed at the August Board meeting. Field Day Critique: Kevin, K9HX, reported that a review of the Club's 2003 Field Day activity could be summed up as EXCELLENT. Issues discussed included a surprising lack of interference between stations, requirements for control operators, operator participation, and possible improvements for food handling in future Field Days. An "unofficial" Field Day menu was unanimously agreed upon to consist of a Friday evening set-up dinner, a Saturday dinner that must include bratwursts, and a Sunday omelet brunch. A need for two additional G5RV antennas and the retirement/replacement of the beam was also discussed. It was decided to present these ideas to the membership for possible "group build" projects. Dave, N9FMD, challenged next year's Field Day coordinator to "top this one." Repeater Issues: Kevin, K9HX, reported the frequency change of the K9IKQ repeater to the new frequency (146.685) was complete. Reports from many stations indicate all is well. The current announcement tape will be used for an additional two weeks. The APRS digipeater has been tuned up to an output of 25 watts. However, there seems to be a problem with the battery and the machine is currently running off of another power supply provided at the site. Generator repairs: No additional action to report. Club station repairs: The rotor has been repaired and a new control cable has been installed at the club station. Vigo County CD generator: The club has taken possession of the donated generator, although

paper work for the transfer still needs to be completed. The generator is currently parked at Dave's, N9YNF, residence. The club agreed to remove the unit from Dave's driveway within a couple of week's. Don, K9DRP, suggested that Chuck, KC9BBJ, be contacted to assess the condition of the generator and to do a feasibility study for bringing the machine into the desired operating condition. Tailgate Party: Board members and any other volunteers will meet at 6:00 AM to set up for the July 19 event. Don, K9DRP, will make arrangements with the Bingo Hall to confirm the start time. Club Picnic: Gary, K9ERE, and Pat, KA9ALI will host The Annual Club Picnic. Swimming will start at 4:30 PM with the meal scheduled for 6:00 PM. Skywarn Seminar: Illiana Skywarn will host a workshop for net control operators on July 26th at 9:00 AM at the WMGI studios (south of the Red Cross) in Terre Haute. Fall Tech Class: Jay, AB9CG, reported that Rose Hulman Ventures has offered to provide classroom space for the fall class. The possibility of the Club maintaining a supply of NOW YOU'RE TALKING was discussed since Radio Shack will no longer stock these manuals. Sunday Net Format: A sample of a new preamble was reviewed for the WVARA Sunday Night Net. Changes to the format were agreed upon and the new preamble will be distributed to net controllers. Contributions: It was noted that the Club did not make any contribution to the World Gospel Church for use of the facility in hosting this year's Brentlinger Dinner. Kevin, K9HX, will contact Dave, N9YNF, to determine an appropriate amount. A motion was made by Ray, K9DUR, and seconded by Dave, N9FMD, to authorize the Treasurer to make payment of \$25.00 to QTH.Net as a donation for hosting the Club's listserver. NEW BUSINESS: Equipment Insurance: The Club has received its annual premium notice from Marsh Affinity Group Services for the equipment insurance plan. Ray, K9DUR, will compile a list of equipment to update the policy coverage. MARS participation: Jay, AB9CG, presented the possibility of the Club station becoming a member of the MARS program. As station manager Jay indicated he could perform the necessary paperwork involved to implement the program. It was decided that the idea would be put forth to the general membership for individual interest in joining the program. Christmas Party: Gary, W9EEU, will contact possible caterers to determine the feasibility of holding the annual Christmas Party at the World Gospel Church. A motion to adjourn was made by Ray, K9DUR, and seconded by Kevin, K9HX, to adjourn at 8:47 PM. The motion was carried.

Board Meeting Minutes 08/11/03

The August meeting of the WVARA Board was called to order at 6:01 p.m. by Club President Kevin Berlen, K9HX. Also present were: Vice President, Gary Adams, W9EEU; Treasurer Don Pine, K9DRP; Secretary Debbie Shorter, KC9AOR; and Board Member at Large Dave Littlejohn, N9FMD. Guests present were Gary Wheeler, K9ERE, and Jay Sotak, AB9CG. There were no announcements. The Secretary's Report was distributed by Don, K9DRP, who took the minutes in July due to the absence of Debbie, KC9AOR. A correction was made to the statement regarding the donated radio, which should have read Yaesu FT-990. Gary, W9EEU, moved to accept the minutes as corrected; Dave, N9FMD, seconded the motion which was approved. The Treasurer's Report was distributed by Don, K9DRP. He reported a balance in the bank of \$2,902.55 prior to sending a \$25 check to QTH.net today. The quarterly report was prepared for publication in *The Bandspread*. Dave, N9FMD, reported that he still has money to turn in from the sale of Field Day t-shirts. Don moved that the Treasurer's Report be approved as distributed; Gary seconded the motion; the motion passed. OLD BUSINESS: (1) Repeater issues were presented by Kevin. He stated that there was not much new to report since the frequency change and coordination have taken place. He reported that Ray, K9DUR, plans to donate the new repeater controller which was discussed in previous meetings as an item we would like to have sometime in the future. He plans to donate it as a memorial to Natalie, K9CAT, as she had expressed a desire to purchase it for the Club. There was discussion regarding the Board's desire to have an engraved tag attached to the controller which would state that this is "in memory of Natalie Andrews, K9CAT." Miscellaneous repeater issues were discussed. Kevin reported that he has inspected the repeater and it is working fine. He discovered a problem with the battery and he is working to remedy the problem. (2) The Civil Defense generator has been picked up and is now at Chuck, KC9BBJ's residence. He reports that it runs well. The manual states that the generator uses 4 gallons per hour. It is a 3-phase generator with a total load of 52 amps per leg. There was discussion regarding the size of the unit, liability issues and expense of operation. It was decided that the Board should postpone further discussion of the use of the Generator pending Kevin's review of the paperwork from the Civil Defense. (3) Fall Technician Class: Classes are scheduled to begin September 2, 2003 at Rose Hulman Ventures. Jay, AB9CG reports that he has a supply of the "Now You're Talking" books available. There was discussion regarding the Club's purchase of books to have available for the beginning of the first class. Gary, K9ERE, will check to see if ARRL will allow us to order books on consignment prior to the classes and return those not needed. It was decided that we will keep one book available for sale, at list price, in the Club Station for potential new hams. When that book sells, we will order another one. It was recommended that at the end of the three-year cycle, we not restock the book for the Club Station. There was also discussion regarding donating a copy of "Now You're Talking" to the public library. (4) The Sunday night net format change was discussed. (5) A contribution to World Gospel Church for the Brentlinger Dinner was discussed. Dave moved and Debbie seconded the motion to send them a donation of \$30. The motion passed. Don will send that in this week. (6) The Christmas dinner location/schedule has not been confirmed. Kevin will check with Dave, N9YNF, to see if we can use the church again.

The ladies from Gary, W9EEU's church are willing to prepare the dinner if the church is available. The tentative date is December 6 (the first Saturday of December) beginning at 6:30 p.m., with dinner at 7. (7) Tailgate report - Don reported that there were 47 paid admissions. There was discussion regarding the decline in attendance over the past several years. Don suggested that we ask those on the listserv for suggestions for improvement - Kevin will do that. NEW BUSINESS: (1) Desk-top publishing program for *The Bandspread* - Gary, K9ERE. There was discussion regarding what is needed to facilitate the publishing of *The Bandspread*. Gary plans to purchase a new computer and would like assistance with the cost of a desktop publishing program; the benefits to a new program include it would make its own pdf files, the newsletter would be easier to put together and the quality of fonts and pictures would be much better. If provided the new software, Gary has agreed to publish *The Bandspread* for at least three more years. Gary will provide more information regarding pricing as soon as his research is complete. (2) Dave, N9FMD, suggested that he would like to develop a column for *The Bandspread* entitled "Dear Dr. Elmer." The column would provide a place for readers, especially new hams, to submit questions and receive a response. Dave would write the column with technical assistance from others as needed. (3) Don presented a fax from our insurance company which included a complete list of equipment to be insured. The list they have is seven years old so it's very outdated. The bill needs to be paid by the first of September. It was decided to pay the premium and submit a new list as soon as Ray, K9DUR, is able to complete it. (4) Jay, AB9CG, reported that he spoke with someone at the Strawberry Festival in June about their communication coordination needs. If the Club would be able to provide three or four people with hand-held radios to assist with their communication needs, it would be and great asset to the workers there and great publicity for amateur radio. The idea was well received and will be discussed again closer to the time of the event. (5) Dave, N9FMD, announced that he will become the Vigo County Emergency Coordinator effective September 1. (6) The September Board Meeting will be held at 6:00 p.m. There being no further business, Debbie moved to adjourn the meeting; Gary, W9EEU, seconded the motion. The meeting was adjourned at 8:20 p.m. -Respectfully submitted, Debbie Shorter, KC9AOR, Secretary.

Introducing the Ryves Hall Amateur Radio Club and Station

Ryves Hall Amateur Radio Club has a successful beginning. KC9EKW is where Every Kid Wins!

KC9EKW is a new call that many will begin to hear on the airwaves. The call belongs to the Ryves Hall Amateur Radio Club which is located in Ryves Hall Youth Center. Jim Edwards, KA9DIF, is the station trustee and director of the youth center. Plans began for the club with a class last November. Since that time two classes have been held with a total of ten licensed hams. Of the ten that were licensed, three were adults and seven were youth ranging in age from twelve to seventeen. In fact one entire family, the Kellers, walked into a Marshall testing session and walked away with their tickets.

Two grants have been obtained to build the new "Ham Shack." The grants were from the Rose Hulman Homework Hotline to increase interest in Math and Technology, and a SIG grant from Chances for Indiana Youth to combat substance abuse. With these two grants the new shack currently has a Kenwood TS-2000, an Astron 50 amp power supply, and four antennas. Several other used rigs and supplies have been donated by local hams. Items still being sought are a tower and rigs that can be given to newly licensed young people to help them get on the air at home.

Without the help of the WVARA and its members the new club would not have become a reality. With not only technical assistance but also elmering, many of our newly licensed youth have been able to put faces on many of our local hams even before they spoke with them on the air. Whether it was Dave, N9FMD, dropping by with his "curtain rod" antenna or Kevin, K9HX, or Chuck, KC9CKK, dropping by to drill holes, there has been a daily presence of amateur radio operators at Ryves Hall.

Ryves Hall Youth Center is a part of Catholic Charities of Terre Haute and is partially funded through the United Way of the Wabash Valley. The youth center has been in operation since 1982 and since January, 2003, there have been over 1200 different children receive services at the center. All programs are free of charge to any child walking through its doors. Most children coming to Ryves Hall come from lower-income families. Activities include Amateur Radio, tutoring, a computer lab, a library, meals, counseling, Boy Scouts, Girl Scouts, substance abuse prevention programs, basketball, arts and crafts, dances, Karaoke, and much more.

Although volunteers and donations are needed for every program there is currently a great need for "elmers" in the Amateur Radio program. Licensed hams are needed to provide one on one elmering to children. One half hour each week would help focus and motivate many children seeking their Amateur Radio license. Many newly licensed hams also need assistance in operating the club station. Elmers could demonstrate the HF bands, and teach proper operating procedures. The youth center could use elmers from Monday through Friday until 9:00pm.

Illiana Skywarn Coordinator, My Old Job

In the past four years as Skywarn Coordinator I have seen much activity and many changes, both in the number of volunteers, available technology and the scope of the organization.

As former volunteers either moved out of the area such as Eric, N9KDB, who was our direct link to Channel 2 radar, or others who have gone on to other interests in Amateur Radio, new volunteers have taken their places and are currently in the process of refining their skills while using the new communications and computer technologies we now have available to us.

Over the past three years, Internet access to more complex and quicker radar sites have enabled area Skywarn nets to more quickly analyze pending weather situations and prepare spotters sooner for what they might expect to encounter.

For the past year, Skywarn has been involved with increasing its scope and coverage of the area due primarily to the initiation of the 444.350 repeater link to Indianapolis, from Farmersburg. It makes it possible for many counties, both in east central Illinois and west central Indiana to gain access to the Central Indiana Skywarn net and the National Weather Service directly without wasting curcial time by having to relay information through one or more stations.

And of course The NWS, in it's yearly spotters' classes under Dave Tucek, KC9CNF, continually introduces us to new techniques for better evaluation of what we as spotters might see.

At the recent Skywarn net controls' seminar, we were extremely gratified to see a very large turnout of those who are either planning to become or are thinking seriously about becoming the "new blood" Skywarn NCS that is so greatly needed at this time.

So it is with the greatest of pleasure that I relinquish the coordinator's spot to arguably the most capable person ever to hold the position, Keith, WA9DRO. Keith brings to the coordinator's spot the benefit of many years as coordinator and a vast knowledge of the geography of the Illiana Skywarn area. He knows the people and has exciting ideas about how to handle the ever-increasing responsibility of Skywarn to the Wabash Valley community as well as the NWS.

Where do I even begin? A very special person has left a huge empty space in the lives of many of us.

I first met Natalie, K9CAT, at a WVARA club meeting in 1996. I remember being glad that there was another woman there who was also a ham and especially when I discovered that she was active in the public service aspects of the hobby -- one of my main interests. As I became involved with more activities, she was always there, too, often taking care of some aspects of the event behind the scenes, assuring that all would run smoothly.

At some time in those earlier years, Natalie first brought up the subject of the YLRL (Young Ladies' Radio League) and started encouraging the rest of us YLs to join the national organization and form a local chapter with the idea of getting local women hams more involved with amateur radio activities. She kept after us and that finally became a reality not too long ago as CAARLA was born and affiliated with the national group. She was our first president -- there was no way we would have settled for a "no" on that!

She kept encouraging Debbie, KC9AOR, to get her license. She pushed and prodded relentlessly in her own way and Debbie went after her license and of course succeeded for which Debbie and all the rest of us are very grateful. I remember her encouraging me to keep trying for my general, and later extra, too.

Then several years ago her battle with cancer began. Through all the ups and downs she never lost heart, and never ceased putting other friends, and even strangers first. She let me know in no uncertain terms that I should have called her the night I had to be taken to the hospital at 2 AM -- she was going through radiation and another round of chemotherapy at the time. She won the LAMB award for her volunteer work with the Red Cross. Many of those calls came in the wee hours and required going to a fire scene, helping provide for the victims and firefighters needs. This too was during her ongoing personal battle. Even in those last weeks, she was on the radio, offering to forward messages for those of us trying to contact someone when we did not succeed.

She was selected as this year's recipient together with Ray, K9DUR, of the Brentlinger Award and no one could have deserved it more. Now we all need to carry on in her spirit. I have a feeling that would please her very much. I, as all of us, will miss her tremendously. She was my cat's very favorite human and beloved by all my dogs who were always delighted to see her and Ray.

Our CAARLA (Crossroads of America Amateur Radio Ladies Association) will regroup and do our best to keep Natalie's dream alive and growing. Thank you Natalie.


