ARRL Proposes Eliminating Technician License

(They want to make them Generals)

On Monday, January 19, 2004, the ARRL released details of a proposal for restructuring the Amateur Radio Service that will be presented to the FCC in the form of a petition for rulemaking within the next couple of weeks. The proposal was adopted by the ARRL Board of Directors at their annual meeting last week in Newington, CT with only one Director voting against it.

The main points of the proposal include reducing the number of license classes from 6 to 3, creating a new entry-level class with limited HF phone privileges, and making some adjustments to the current phone/CW allocations on the HF bands. The complete text of the press release may be found at http://www.arrl.org.

Under the proposal, the only license classes would be Novice, General, and Current Advanced Class licensees would be grandfathered to Extra, and current Technician Class licensees would be grandfathered to General. There would be a 25-question written exam for the new Novice Class and no Morse requirement for either the Novice or the General. The 5 wpm requirement for the Extra Class license would be retained. Novice class licensees would be given phone privileges on 80m, 40m, and 15m in addition to the existing phone privileges on 10m. The Novice Class would also have phone privileges on 6m, 2m, 220 MHz, and 440 MHz.

It should be emphasized that this is only a proposal and not yet even a petition. If this proposal is adopted, in any form, it probably would not be until sometime next year before the new rules would go into effect. After the petition is filed, a period of time for comments on the petition will be announced by the FCC.

For further details on the proposal and on the reasoning behind the ARRL's position, plan to attend the February club meeting.

Board Meeting Minutes 01/05/04

The meeting was called to order by Club President Kevin Berlen, K9HX at 6:06 pm. Present were Treasurer, Don Pine, K9DRP; Trustee, Ray Andrews, K9DUR; Past President, Steve Shorter, NT9T and Secretary, Debbie Shorter, KC9AOR. Guests present were Dave Littlejohn, N9FMD, Dave Pifer, N9YNF, and Chuck Procarione, KC9CKK. Debbie moved that the Secretary's Report be approved as published in The Bandspread; the motion was seconded by Ray and it passed. The Treasurer's Report was presented by Don, who reported that the balance on hand is \$3,755.26 in all accounts. He also reported that, as of today, the Club has fifty-nine members. Don moved that we accept the Treasurer's Report as presented; Steve seconded the motion. There was discussion about Life Memberships and it was decided to place the fees from the Life Memberships into a money market fund; Don will transfer \$900 into the money market fund. There being no further discussion, the motion to approve the Treasurer's Report passed. Old Business: (1) An ongoing discussion regarding General meeting locations was resumed. New Business: (1) Kevin appointed Chuck Procarione, KC9CKK, as Board-Member-at-Large for 2004. Ray moved to accept Chuck as Board Member-at-Large; Steve seconded the motion. The motion passed. (2) Regarding Bandspread deadline - Kevin noted that the deadline of the 15th of each month needs to be more firm for all articles to be turned in to the editor. Dave, N9YNF, will look into reminder notices going out several days in advance of the deadline. In addition, regarding the assignment board, Dave, N9FMD, said they need more input and more people submitting articles. He also said that accompanying pictures are also welcome. Ask Dr. Elmer

Dear Dr. Elmer...

Q. When several of us are physically near one-another, using different radios and working through a repeater, I can almost always hear a distant station but often cannot hear the stations I am standing next to.

This seems to be more common when we are using mobile radios close together, say in a parking lot, than when we use our handhelds, and it seems to go away when we get farther apart. What is going on?

The problem you describe is called "desense" Α. because the station you are close to is desensitizing your receiver. In simple terms, the nearby transmitter overloads your receiver, and can occur even when the nearby transmitter is operating on a different frequency than the one you are listening to. The solution to the problem is to avoid that overload, either by increasing the distance between you and another transmitter, or by asking the other station to use the least transmitter power that still allows the communication.

After the speech Otis sat down to a long line seeking his autograph. Many brought their new basketballs received at the Christmas Party to be signed by Otis.


