FCC: DROP CODE FROM ALL LICENSE CLASSES

FCC Proposes to Drop Morse Code **Requirement for All License Classes** (Jul 20, 2005) -- The FCC has proposed dropping the 5 WPM Morse code element as a requirement to obtain an Amateur Radio license of any class. The Commission recommended the change to its Part 97 Amateur Service rules in a Notice of Proposed Rule Making (NPRM) in WT Docket 05-235. Any rule changes proposed in the NPRM would not become final until the FCC gathers additional public comments, formally adopts any changes to its rules and concludes the proceeding by issuing a Report and Order (R&O) spelling out the changes and specifying an effective date. That's not likely to happen for several months. The FCC declined in its NPRM to go forward with any other suggested changes to Amateur Service licensing rules or operating privileges beyond elimination of the Morse requirement.

Board Meeting Minutes 07/11/05



Debbie moved that the Secretary's **Report** be approved as e-mailed to the Board; Dave N9YNF seconded the motion and it carried. The Treasurer's Report was presented by Chuck who reported a balance in all accounts of \$4,510.99; the only outstanding bills are the \$50 hall rental for Field Day and our Club insurance. Chuck moved that the Treasurer's Report be approved as presented. Dave, N9YNF, seconded the motion and the motion carried. The MonstIR Antenna



One of this year's featured attractions at Field Day was the MonstIR by SteppIRTM<www.steppir.com>. As its name implies, it is nothing less than a "Monster" antenna and tower system.

Provided by Joe and Melanie Clotier, it was an imposing addition to the landscape at the Cory Field Day site. (See accompanying pictures.)

Mounted on its own trailer - nothing else is big enough to carry it - it is truely the largest multi-band ham antenna yours truely has ever seen "in the flesh."

It provides 3 Elements on 40M and 30M, 4 Elements on 20M, 17M, 15M, 12M and 10M and 6 Elements on 6M. Unlike most antennas which are "tricked" into thinking that they are different lengths by the use of traps or inductive matching devices, this antenna really IS all these different antennas rolled into one; a monobander on every band - no mean feat!

Weighing in at 215 lb, its longest element is 70 feet on a 34 ft. boom. All this sits on a trailer equipped with its own telescoping tower and built-in generator, all on top of a dual-axle chassis built to hold it all.

Joe told me that he and Melanie wanted to provide a meaningful addition to the WVARA Field Day effort and they certainly did!
