Triathlon Defined

A triathlon is a multi-sport event involving the completion of three continuous and sequential endurance events. While many variations of the sport exist, triathlon, in its most popular form, involves swimming, cycling, and running in immediate succession over various distances. Triathletes compete for fastest overall course completion time, including timed "transitions" between the swim, bike, individual run components. The word "triathlon" is of Greek origin from trei (three) and athlos (contest).

The nature of the sport focuses primarily on persistent training in each of the three disciplines, as well as combination workouts and general strength conditioning.

We were so intent upon getting the bike out of the ditch and loading it into the truck that we forgot to get any photos of that part of the event. Sorry 'bout that.

He was apparently not hurt seriously but they did take him to the hospital. This underscores the need to have every position covered so paramedics can be alerted, if necessary, and can respond as guickly as possible.

As the last participant in each race passed each station on the course, that person could return to the park for free sandwiches and a drink. Then they were free to hang around or leave, as they wished... that is, except for the net controls and others of us tasked with the job of takedown and putaway at the trailer. But everyone pitched in and stuff was put away in a short time.

We'd like to sincerely thank all the folks who volunteered to help staff the event and help with the setup and takedown afterwards as well. It was apparently enjoyed by all as many of them have already volunteered to show up again next year. Since we are competing every year now with the Dayton Hamvention, this

spirit of participation is very gratifying to those of us who have to coordinate the event!

The meeting is open and everyone is welcome to attend. (2) Testing session in Paris, IL on Saturday, May 12, at 8:30 a.m. Illinois time, at the Burkeybile Law Office. (3) CAARLA meeting will be at the Glas-Col Club Station on Saturday, May 12, at 1:30 p.m. (4) No QCWA meeting this month. (5) Terre Haute Triathalon will be Saturday, May 19. Volunteers are needed. Someone has offered \$3300 to fund this, but the club needs to approve. \$3300 will cover the cost of cavities and filters. There would be some additional cost of approximately \$1,000. Motion was made by Ray K9DUR that the club authorize expenditure of up to \$4500 for the remote repeater. John N9YRX seconded. Motion carried. (4) Dave N9FMD mentioned that several hams have recently loaned equipment to newly licensed hams. There was discussion regarding what the club might be able to do to help new hams to get on the air. Some club members said that they may have some old power supplies, etc. that they may be able to donate for this purpose. Ray K9DUR volunteered to research the cost of two 10-12 amp power supplies that the club might purchase that could be loaned to new hams. (5) The topic of the evening's presentation by Ray K9DUR was the ARRL Official Observer Program. (6) Meeting adjourned at 8:25 p.m.

The WVARA Board met on Friday, May 4, 2012. The meeting was brought to order at 8:44 p.m. by Steve Shorter, NT9T. Ray, K9DUR also attended. **Secretary's Report:** The Secretary's Report was approved as printed in The Bandspread. **Treasurer's Report:** The Treasurer's Report was presented in the form of a motion by Jeff with a total of \$12,699.86 in all accounts. Kevin, K9HX, seconded the motion. Motion carried.

Old Business: (1) Kevin, K9HX, announced that the equipment for the antenna system at the Vigo County jail site is on order, and should arrive in about two weeks. Kevin has also purchased a receiver multi-coupler on E-bay and will be presenting the bill to the Treasurer as soon as the item is received. (2) MOU's were discussed for Clark, Clay, and Vigo counties. Gary, W9EEU, passed out copies of a draft for the Clay County MOU, and will be discussed again at next month's meeting. Fuel budget for Clark Co. RV—There are funds set in the budget for this purpose, and the Board felt that it was a worthwhile expense and that the van should be kept fueled and ready.

(1) Field Day Planning. Gary, W9EEU, **New Business:** announced that volunteer slots are open and need to be filled. All operating rigs are lined up with the exception of one. Readiness of antennas, computers, software, etc. was discussed. It is hoped that after set up on Friday night we will be ready to operate on Saturday. The EMA has expressed a desire to bring their trailer to Field Day and there was discussion as to how it could best be used. T-Shirt orders will be taken at the general meeting of the WVARA in June.
