The History of the Brentlinger Award

Uncle Bill Brentlinger died a few months before I was born. Both uncles had been wheel chair bound since middle school. Professor Ted Hunter, at Rose Hulman, received a grant to teach Amateur Radio to handicapped people. Uncle Bill was chosen as his first pupil. He successfully passed what was called the "C" (Conditional) license. Bill died in 1935, shortly before I was born. Then Jack got his license. This was where 'Little Teddy' got 'the bug'. Jack needed help with National HRO receiver with its knobs to turn, plug-in coils to switch and taps on the long wire antenna - things Jack physically could not do. He was active on 160 & 10 and plus 40 meter phone and CW. The transmitter was a homebrew by Herman Moench and Ted Hunter, who, at the inception of the Brentlinger Award, were the first two honorary recipients of the award.

And the rest is history!

Clay County ARES 2-Meter Repeater



A project that was more than a year in the planning stage became reality on Friday, March 29th, when the Clay County ARES repeater on 145.420mHz was installed at its permanent location on a tower near Center Point, Indiana. The system is running without tone (PL) access.

With the cooperation of Bryan Husband, Clay County EMA Director, and the Clay County Board of Commissioners, permission was granted for the installation of this system on a tower owned by Clay County near Center Point, Indiana. This tower is on some of the highest ground, and very near the geographical center of the county. This location is home to several Clay County public safety radio systems, including other VHF-FM repeaters for the Clay County Sheriff, Fire service, EMS, and County Highway department, as well as two VHF digital repeaters for Clay Community Schools.

A frequency for a new 2-meter system was applied for through The Indiana Repeater Council. Despite the 2-meter band being heavily populated with other systems, Coordinator Charlie Sears, N9MEW was able to find what is known as a "splinter" frequency. Our frequency falls between two standard repeater frequencies, but fits the criteria for formal coordination with the IRC.

Once we had secured a frequency pair, and access to a suitable site, we began the process of putting the necessary equipment together. A retired commercial repeater was available, and a duplexer and controller were located at the Dayton Hamvention last year. The system was assembled and went on the air for testing late in 2012 from W9EEU's location in Cory.

The intent of this system was to provide coverage to mobile units within the footprint of Clay County, so we were not looking for a high profile tower site or installation. The repeater has an ERP of approximately 50 watts, and the antenna is installed at 120 feet AGL. All reports received so far indicate that this goal has been realized. We have had mobiles accessing the site from each of the surrounding counties with good signals. Base stations as far away as 85 air miles have accessed the system as well.

Clay County EMA also funded purchase of a new commercial grade antenna for this project, and professional installation of the antenna system was funded through a grant from First Financial Bank.

Clay County ARES is looking to continue to build upon this foundation, and would ultimately like to have a SkyWarn net in Clay County to complement Illiana SkyWarn operations. We are in the process of setting up a well-equipped amateur station at the Clay County Justice Center, in a room near the 911 dispatch center. Antennas have been installed on the roof of the building, and this station will be operational later this spring. This station will be manned whenever there is severe weather in the area, and during other times as necessary to help supplement communications within the county and to entities outside the county.

Clay County ARES conducts a 2-meter net on this new repeater every Monday evening at 9:00PM Eastern time. We meet the second Monday of every month at 6:00PM Eastern at Four Loving Paws Veterinary Services, located at 965 W Craig Ave in Brazil, IN.


