ual County Hunters CW Contest, the ARI International DX Contest, the International Police Association Contest, and the New England QSO Party (Maine, New Hampshire, Vermont, Massachusetts, Rhode Island and Connecticut) will all be on the air during our operation. Dear Dr. Elmer...

I've been hearing people talk about "white noise." What is it, and where does the name come from?

"White noise", as it's called now, is simply the rustling sound that you hear when you open the squelch control of your radio with no signal present. It could also be called "static" on an AM radio, and it goes away in proportion to the strength of a signal. A strong signal completely replaces the noise and that condition is called "full quieting". while a weak signal may replace only a portion of the noise.

There are several theories about where the words came from, but the most interesting, and least often explained, theory comes from secret military research begun before the Vietnam War, and it may be continuing to this day. We can't verify the veracity of the theory, of course, because the programs are still classified. We are only now hearing about pieces of the work, so you have to consider the source.

It seems that submarine captains were having trouble knowing their location while under water, so a project was begun to assist them. The project scientists were already familiary with Sonar, so they attempted to couple sounds, which is the heart of Sonar, into a position-finding system. Low-frequency audio sounds were sent into the water from various locations, using very high power transmitters. Each of these were encoded to indicate their location.

"Blue Noise" was the tern used to identify sounds that actually went into the water. (As in "the ocean blue.") At the same time "Green Noise" was sent directly into the ground. (As in "the green green grass of home.") White noise was transmitted into the sky. (As in the white puffy cumulous clouds of summer.)

It is not clear whether or not the system worked, but at least two of the modes had to be discontinued, or at least that was the report. It seems that blue noise may have had an adverse affect on ocean mammals, maybe resulting in several reported dolphin killings (as recently as January 2005.)

The green noise part of the experiment is also believed to have been discontinued. There are two theories as to why this was stopped, but of course nothing has been said officially. The most common is that other government researchers became concerned about the possible effect of these sound waves on earthquake incidents. Nothing could be confirmed outside the program's security, so it was never really known if the sound created earthquakes or not.

The other theory was that submarines often had difficulty telling the difference between the authentic green noise transmissions and the sounds originating from various rock concerts of the 80's. Since many of the concerts were held on the east and west coasts, near the ocean, this theory was never ruled out.

There haven't been many reports concerning the experiments with White Noise, however we continue to hear the signals whenever we open the squelch on our radios. So it may be continuing to this day.

There is not much else known about these experiments, in the interest of national security. However, the program name for the experiments does

appear from time to time, and may be worth watching for. The official program was conducted by the Society Promoting Oceanic Orientation Fundamentals, or SPOOF for short.

ARES/Skywarn Pagers Are Here



Wabash Valley ARES and Skywarn will become one of the first in the nation to make pagers available to its' members, when a new paging capability becomes available this Spring. The new system will be a combination of new capabilities installed in the 146.685 repeater last year, and an availability of fire department pagers that became available when Vermillion County replaced its' fire department pagers last year,

The new capability will make two-tone pagers, recrystalled onto the WVARA 2-meter repeater, available to members for a small acquisition fee. These pagers operate in two modes, as a standard squelch receiver, and as a pager. In the receiver mode the pager will provide the user with a small receiver tuned to the 146.685 repeater. In the alert mode, the pager remains silent until appropriate tones are sent by a control station. At that time they will sound an alert tone, and then whatever messages are being broadcast over the repeater.

Each pager also comes with a drop-in charger to keep the internal rechargable battery ready for use. That charger also includes an audio amplifier and antenna to keep the paging system ready for use at home.

The pagers became available after Vermillion County fire officials received funds to update their paging system. The acquisition fee, expected to be about \$30, will be used to purchase crystals for the WVARA repeater, and possibily other needed parts. The ability to send paging tones over the Club repeater is one of the benefits resulting from the installation of a new repeater controller last summer.

The pagers will be used to alert members concerning some sort of local emergency operation, including use in the Skywarn weather spotter system. Some tests and other experimentation will be needed to determine the range and other characteristics of the new equipment. Additional information may be obtained from Dave Littlejohn, N9FMD.
