It is with the greatest of pleasure that we announce that the WVARA is now an officially designated non-profit organization according to the state of Indiana and the U.S. Department of Treasury, but we'll let our president, who is most responsible for its becoming a reality, tell us more.

## The President's Corner

I was elected to serve the WVARA as your treasurer some years ago. Like many things I don't really want to think about how long ago!! I can recall that shortly after assuming office, the WVARA Executive Board discussed the possibility of applying to the IRS for tax-exempt 501(c)(3)status. The application process is а little cumbersome and the application fees caused us to table the idea at the time. In recent months the idea seemed to resurface. I researched the possibility, and downloaded the application along with the instructions from the IRS website. It took a fair amount of time, a lot of reading, and a trip to Indianapolis by my wife, but the application was completed and sent to the IRS. After a couple of weeks corresponding with the IRS (boy is that fun) we have received a letter of approval from them.

Being a 501(c)(3) corporation, means that contributions to the WVARA can be tax deductible to the donor. It also makes it possible for the WVARA to apply for various grants and private foundation gifts that are given only to tax-exempt organizations. We are also qualified to receive tax deductible bequests, devises, transfers or gifts under certain sections of the tax code. Hopefully this will help provide funding for projects the WVARA wants to pursue in the future, and should be a positive thing for us.



So if you know of any individuals or organizations that are looking to make a tax-deductible contribution, let them know that the WVARA is a tax-exempt organization, and that their donations to the WVARA can be tax-deductible. Many thanks to those who helped make this possible.

The Secretary's Report was approved as published in The Bandspread. Treasurer's Report: Chuck, W9COD, reported a balance in all accounts of \$5,353.57 and moved that the report be approved as presented; Kevin seconded the motion and the motion carried. Old Business: (1) Generator repairs were discussed. Chuck will follow up on trying to get that accomplished. (2) Repeater upgrade: A cost estimate has been obtained, the Reelsville site has been confirmed and Kevin will follow up on the Graysville site. (5) Program schedule was discussed. (6) It was decided to have a tube sorting party along with a silent auction, June 3, at Don's QTH at Bullskin, IL. ## THE LONG-AWAITED CLUB STATION RADIO DESK UPGRADE

The long-term procrastination over the remodeling of the Club Station radio desk is finally at an end!

K9ERE, with the help and advice of WB9ZHC, Club Station Manager, K9SGL, K9HX and some painters, who may not want to be indentified, nearly finished the project on March 30. (It took about another week to reconnect the equipment.)

The radio desk was originally designed and built by Jim, K9VDQ, to fit in its current location. Jim had the foresight to assemble it with screws to facilitate its removal if ever it were deemed necessary. In accordance with that design, the remodeling was also done entirely with screws.

Over the years, the radio desk has undergone numerous minor modifications but it was felt that a further redesign was necessary at this time. The original shelves were insufficiently supported, causing them to sag and tilt forward. The HF radios, which require constant adjustment and knob-twiddling were positioned high up where one had to reach up too high to get to them while the UHF and VHF radios which require relatively little manual adjustment were down low.

It was decided that the HF equipment should be positioned low enough that the operator can rest his or her elbow on the desktop and reach the most-used controls, while the UHF/VHF equipment would be put higher up since they required only occasional attention.

It was also decided that a computer, probably in the form of a laptop someday, might be necessary at times for logging a contest or emergency situation. Center stage was probably the best place for it. So a space was left between the bottom left and bottom right HF shelves for this. It would give each HF station access to the computer and provide maximum possible separation between the two HF operating positions.

It was also desirable to provide a completely unobstructed desktop for writing. In order to provide this clear space and at the same time provide sufficient support for the HF shelves, it was decided that they might better be supported from above. So a pair of large diameter dowels were employed, which were firmly attached to the bookshelf above. This accomplished both goals.

We are grateful to all who helped in suggesting design goals and to those who actually helped produce the finished product. -ed.


