

WVARA OPENS NEW CLUB STATION

It was a beautiful Spring morning just days before the Bison Stampede aka the Indiana QSO Party, as a bunch of us got together to punch holes through nearly 70-year-old concrete blocks (they made them to last back then), run coax, climb ladders (and a forklift) to erect two new antennas and set up the rigs for our new Club station. Following is text from Ray along with numerous photos of the auspicious day (see pp. 6-8).

[Excerpted from an article by Ray Andrews, K9DUR.] -ed.

The Wabash Valley Amateur Radio Assn., W9UUU, [has put] together a 2nd club station. The 2 locations are both in Terre Haute, about 1 mile apart. The old station is located in the basement of the local Red Cross chapter and is equipped with a Ten-Tec Corsair and a Yaesu FT-990. The new station location is in a building owned by the Glas-Col Corporation. [It] has an Icom IC756-Pro II and a Yaesu FT-950. The antennas are a GAP Titan DX and a home-brew 160m offcenter fed dipole. The dipole is not very high above the roof of the main manufacturing building, so it is probably a bit of a cloud-warmer. However, that should be just right for the INOP.

We managed to get the HF antennas installed at the new location a week before the INOP so that we could operate from both locations for the Bison Stampede held in conjunction with the INQP.

I do not have all of the logs yet, but the total number of QSOs was just under 250, about 90 from the old station and a little over 150 from the new station. Virtually all QSOs were on SSB. Next year we should be better set up for CW operation.




