The WVARA Board met on Saturday, August 11, 2012. The meeting was brought to order at 6:00 p.m. by Steve Shorter, NT9T. Secretary's Report: The Secretary's Report was approved as published in The Bandspread. **Treasurer's Report:** The Treasurer's Report was presented in the form of a motion by Jeff, AB9WR, with a total of \$15,035.76 in all accounts. Gary, W9EEU seconded the motion. Motion carried.

Old Business: (1) Work on the repeater upgrade is progressing at the jail. Equipment has been installed and is waiting to be connected. RA-COMM has been paid and we have been reimbursed. The staff of the Bandspread has undergone several changes since the first of this year due to many reasons. At this time it appears we are looking at making some more changes in the staff and possibly even to the format.

We are looking currently looking for someone to become the Editor. These duties will include, but not necessarily be limited to, finding content, deciding what to publish, the position of the particular items, and getting the product to the publishing personnel (both on-line and hard copy) in a timely manner.

The Editor should be aware they might often have to twist people's arms and otherwise coerce them into writing and preparing articles. It may, (probably) be necessary to write some articles themselves.

More Repeaters Grace the Skyline

As repeater systems continue to illuminate the skyline, and continue to dominate our day to day activities on VHF and UHF bands, it might be a good time to pause and look around at plans already in progress for the future. Bandspread readers have come to depend upon a monthly reminder on the front page detailing what's out there and now there are at least four new systems in various stages of development that may soon join the list.

The WVARA system will soon benefit from an additional receiver site located in downtown Terre Haute. This new receiver is expected to greatly enhance portable and other low power systems operating in the area by listening to our normal input frequency, and sending what it hears to the main repeater near West Terre Haute. When in operation that signal will be compared to signals from other receivers already in place, and the best signal will be repeated. Equipment to accomplish this task is called a "voter," and is already in place. Operators using the system will not need to change operating habits in order to benefit from the changes.

Another new VHF repeater is in development by K9HX, and is located at the former State Police post south of Terre Haute. That repeater, operating on 146.805 MHz, no PL, is currently on the air in a low-profile status. Local ARES officials have indicated their intention to conduct operations of that system. Exact completion dates have not yet been announced but the system is on the air and working as of this writing.

Clay County will soon benefit from a new repeater being installed in that area. Gary, W9EEU, has announced that their new VHF system will operate on 145.420 MHz, no PL. Completion dates and other details are not presently known.

East-Central Illinois operators are not being left out of the game, with a recent announcement by John, N9YRX. He said, in an e-mail message in July that a new repeater will soon be operating from a site near Grandview, IL. He said the location, southwest of Paris, will utilize a retired AT&T microwave tower. Other details, including operating frequencies, have not been announced.

The expansion of repeater coverage in the area must be considered with one eye to the sky and the other to the ground. There must always be a plan in place for the day when even the best of systems fails.
