The October club meeting will feature special speaker Edmund Harfmann from the Society of Amateur Radio Astronomers. This should be a very interesting presentation and all are welcome.



Wayne IN, and while being coached was able to make her first ever amateur radio contact. What drew special attention is that Chuck had several stations calling and he made all stations stop and wait while he worked the YL. It was apparent during the contact that the YL was being coached through the exchange and Chuck patiently worked with her until the contact was in the log.

On the Monday morning following Field Day, there was traffic listed for Gary W9EEU on the NTS net, which ended up being a special note of thanks to the WVARA Field Day operation. What made the contact so special was, not only was this Sammi's first ever amateur radio contact, Sammi is also vision impaired. The report from the Ft. Wayne group is that the experience really "made Sammi's day".



Word of the contact made it all the way to ARRL Headquarters, where a Public Service Commendation was issued to Chuck. It is just an example of the good that can come from amateur radio. Proposed Criminal Background Check Policy

The board has approved implementation of a background check policy for all members of the Association. *This policy will be presented to the membership for a vote at the October meeting.* Please review the proposed policy and direct any questions you may have to a board member.

Wabash Valley Amateur Radio Association, Inc. Criminal Background Check Policy

The Wabash Valley Amateur Radio Association, Inc. (WVARA) endeavors to work with many public organizations and has determined that a criminal background check is required as a condition of membership in the WVARA. The criminal background check is regulated under the Fair Credit Reporting Act (FCRA) and as such the screening policy form contains language permitting an extensive background search, however the WVARA will not ask for any credit history as a part of this criminal background check process. The WVARA will only conduct a national criminal background check, a social security number trace, and a county records search for any felony convictions on record.

Any individual desiring to be a member of the WVARA must consent to a criminal background check prior to being granted membership. Any individual that has a felony conviction on record will be considered ineligible for membership in the WVARA. Any individual refusing to consent to a criminal background check will be considered ineligible for membership in the WVARA. The cost of the background check will be borne by the WVARA.

Existing members must consent to a criminal background check in order to maintain membership in the WVARA. An existing member having a felony conviction on record will have their membership in the WVARA revoked. Any existing member that refuses to consent to a criminal background check will have their membership revoked. The cost of the background check will be borne by the WVARA.

The WVARA will utilize the services of Reference Services, Inc. located in Evansville, IN. If the background check reveals a felony conviction, the applicant will have the right to appeal the report to Reference Services, Inc. for accuracy. The findings of Reference Services, Inc. will be final following the appeal process.

It will be the responsibility of the Vice-President and the Trustee of the WVARA to maintain the reports generated by Reference Services, Inc. They will only report to the WVARA Board of Directors that an applicant is eligible or ineligible for membership as a result of the background check. All information from the reports will be held in strict confidence, and any copies of the reports maintained will be stored in a locked and secure location with access only by the Vice-President and the Trustee.

Evansville Hamfest Closes

EARS and The Ham Station regret to announce that the Evansville Hamfest has ended. For 21 years, EARS has worked hard to bring you the best hamfest we could. The Ham Station has been our corporate sponsor for the last several years, and has been along with us every step of the way. We can not offer enough thanks to all of our vendors (a few of which have also been there every single year), the people who attended, the Old Post Amateur Radio Society who provided concessions every year, the VE testing crew, and those who graciously volunteered with security, ticket sales, labeling flyers, giving out prizes, QSL checking, and more. We hope you will continue to patronize our vendors online and/or at other hamfests.

Several people have asked why the hamfest is ending. There were many factors that we had to consider, including: a date conflict with some vendors for this year, rising expenses of the 4H Center, low attendance, lack of profit, and loss of manpower to help prepare and run the hamfest. We explored other locations, other dates, and other staff. We were unable to come up with a plan that would work. We do not have any plans to revive the hamfest in the future at this time. Most of the original EARS volunteers have moved away, and some have traveled long distances to keep the show running. And, due to lack of use EARS transferred the 145.15 repeater over to the W9WIN repeater network 2 years ago. EARS still operates 146.925 and 443.925 repeaters in Vincennes, along with Echolink and IRLP. Our audio stream is still online, we are still connected to the Central Indiana SKYWARN network, and our online RADAR and weather alerts will continue to serve areas of Southern Indiana as long as possible.
