President's Corner

I hope everyone is having a great summer. Those families with young children going back to school have to adjust to new school and after-school activities and carpool schedules. For me this summer seems to be flying by and my projects seem endless and never ending.

Because of a busy personal schedule, I haven't been able to devote time to the Communications Trailer project. One of my recent projects was analyzing the 2018 Property Tax Assessment we received. The assessor raised our assessed valuation for the Club property from \$6,500 to \$24,400 - a 275% increase. I have had conversations with the Assessor's office and received information about the whys and wherefores of the increase.

The man I spoke with in the Assessor's Office agreed with one point I made which will reduce the assessed valuation by \$260 but he would not agree with my other reasons for a reduction of assessed value. Therefore, I will be filing a Form 130 "Taxpayer's |Notice to Initiate an Appeal' of the assessment based on a number of factors I believe should reduce the assessed value.

I will report my findings at the Board Meeting Thursday, August 23 and to the Members at the General Meeting Friday, September 7th.

Those of you who received similar increases in your assessed valuation only have until Monday, August 27th at 4:00 PM to file Form 130 to appeal your assessment at the Assessor's Office.
