In 2020, the WVARA will set up for Field Day at:

United Steelworkers Grounds E Quinn Ave Terre Haute, IN

(39° 33' 59" N -- 87° 22' 49" W)





Go to the intersection of US Hwy 41 and Budd Rd (red circle on aerial photo).

- If you are northbound on US Hwy 41, Budd Rd is the 1st road past Hasselburger Ave (4.8 miles north of Fort Harrison Rd). Turn left (northwest) onto Budd Rd.
- If you are southbound on US Hwy 41, Budd Rd is the 1st road south of the intersection of US Hwy 41 and Clinton St. Turn right (northwest) onto Budd Rd.
- If you are northbound on Clinton St, Budd Rd is the 1st road north of the Heritage North Animal Hospital. Turn left (west) onto Budd Rd.

Proceed northwest on Budd Rd. It will curve to the left and beome Quinn Ave. Proceed west on Quinn Ave to the 2^{nd} road on the left (0.2 mile from US Hwy 41). Turn left (south) and proceed to the Field Day site at the end of the road.

If you plan on taking the Amateur Extra, this will be the last time you can take it under the current question pool. New question pool takes effect in July.



Driving Directions

From the south (US 41, US 150, or I-70)

- Go north on 3rd St (US 41 & US 150) to 5th stoplight north of I-70 (Farrington St.) Do not count stoplights for I-70 on/off ramps. Farrington St. is 1.7 miles north of I-70.
- Turn left (west) onto Farrington St.
- Go to stoplight (1st St.).
- Continue west on Dresser Drive into Fairbanks Park.
- The Vigo County YMCA will be the 1st building on your left.

From the east or west (Wabash Ave or US 150)

- Turn south on 1st St. (west side of Vigo County Courthouse)
- Go to 2nd stoplight (Farrington St/Dresser Drive)
- Turn right (west) into Fairbanks Park.
- The Vigo County YMCA will be the 1st building on your left.

From the north (US 41 or IN 63)

- Go south on 3rd St. (US 41) to Farrington St., which is 0.6 miles south of the courthouse.
- Turn right (west) onto Farrington St.
- Go to stoplight (1st St.).
- Continue west on Dresser Drive into Fairbanks Park.
- The Vigo County YMCA will be the 1st building on your left.
